Gentlemen,

Let me begin by stating unequivocally that the purpose of this letter is to inform each of you that although I come to you with a sense of urgency, in no way should you consider my urgent pleas to be threatening, harassing, or intimidating in any way. In fact, the intention of my outreach is quite the opposite.

As you gentlemen are already quite aware, the FBI has been the subject and center of very negative press, and I am reaching out to my local FBI representatives in a sincere effort to turn public perception into a positive direction.

On Tuesday October 4, 2022, Fox News's Tucker Carlson broadcast an interview with former Biden family business partner Tony Bobulinski. During the interview, Mr. Bobulinski stated that the FBI allegedly perpetrated a cover-up of crimes committed by members of the Biden family, actively and intentionally suppressed information from reaching the public, and ultimately participated in influencing the outcome of the 2020 election. In my well-informed opinion, the FBI's misconduct is responsible for influencing the outcome of the 2020 election. It is also my opinion that there were individuals within the FBI who are responsible for the misconduct but not the entire institution of the FBI.

Until Bobulinski's interview with Carlson, the American public could only speculate on who was responsible for influencing the election, or how it may have happened. On January 6<sup>th</sup>, Americans travelled to DC in hopes of being heard and present when Congress voted to "push the pause button" for 10 days and investigate reports of wide spread election fraud on November 3, 2020. On January 6<sup>th</sup>, Americans who attended the rally suspected there was election fraud and interference, but were not certain who committed the fraud, or was involved in the effort to overthrow the United States of America on election day.

Now we have a witness, documentation and testimony that clearly implicates the FBI's involvement in influencing the 2020 election by obstructing justice. Although the FBI was not exclusively involved in influencing the outcome of the election, their cover-up of the Hunter Biden laptop story as well as their misconduct in the Bobulinski investigation was consequential, to say the least.

On Wednesday morning, I contacted the FBI field office in Washington DC to submit a formal complaint and ask for an investigation of those within the FBI who were involved in the cover-up of the Bobulinski information, as well as the influence operation to conceal the Hunter Biden laptop story.

Additionally, I contacted my local Cincinnati Field Office to also ask for a formal investigation. Unfortunately, I was transferred to the FBI's Washington DC intake line where I was dismissed and hung up on. During my calls, I informed the persons at intake that I was urgently "*demanding*" that the FBI publicly announce that they are investigating who within the FBI covered up the Bobulinski information, that in light of the information revealed on the Tucker Carlson broadcast, that the FBI would re-open the Bobulinski investigation, and additionally, the FBI would investigate the individuals who were involved in influencing the 2020 election prior to the November election.

The only reason for demanding a response by the FBI by October 19<sup>th</sup> is due to the fact that the November election is fast approaching, and if the timeline for a public response is unreasonable, you should petition authorities to delay or postpone the election pending outcome of your investigation. The American public deserves to know who they'll be voting for in the midterm elections.

My outreach to your office is sincere; genuinely intended to appeal to my fellow Cincinnati's in the FBI field office who have the authority to receive my bonafide complaint, and inform the public that the misconduct of a few FBI agents does not reflect the overall integrity of the entire FBI as an institution. My sincerest intentions are to partner with individuals at my local Cincinnati FBI field office to develop positive public relations, at least here in Cincinnati.

Unfortunately, due to the misconduct of a select few individuals within the FBI, our country is in crisis. If the FBI had not intentionally influenced the 2020 election, covered up serious crimes alleged in the Bobulinski complaint, and if they had not ignored substantial forensic evidence of electronic voting fraud, our nation would not be spiraling out of control.

Per my original formal complaint and demand or a timely and public response from the FBI, the following is a list of reasonable demands I'd like to formally submit to your office. Of course, the "demands" are lawful. I am asking that the FBI do the bare minimum level of investigation and stop covering up the truth. You can elect to continue to cover-up alleged crimes perpetrated by the Biden family and continue to influence elections with your silence and misinformation, but that will not keep me or my fellow Americans silent.

Please take action and publicly respond to the following before or no later than October 19, 2022:

- 1) Re-open the investigation into the information provided by Tony Bobulinski regarding crimes allegedly committed by the Biden family.
- 2) Investigate the FBI agents who were involved in suppressing the Hunter Biden laptop story in advance of the November 2020 election.
- 3) In light of the overwhelming exculpatory evidence that proves their suspicions that the 2020 election was stolen, petition the federal courts to immediately release all January 6<sup>th</sup> defendants being detained pending trial.
- 4) Immediately return whistleblower Dennis Montgomery's disk drives which were presented to FBI Senior Counsel James Baker, and investigate who is responsible for the missing hard drives which reportedly contained evidence of illegal surveillance of Israeli intelligence officials by non-government actors. Based on information obtained in my investigation, 53 disk drives were intended to be submitted to the FBI, and 6 went "missing". Additionally, the disk drives contain evidence of crimes perpetrated upon the United States of America including, but not limited to the most serious potential crimes: illegal surveillance of American citizens, illegal surveillance of U.S. Supreme Court Justices presumably for the purposes of blackmail since evidence of criminal activity was never prosecuted, as well as evidence of electronic voting machine manipulation.
- 5) Immediately cease & desist all cover-up activities and operations conducted by the FBI for the purpose of intimidating potential witnesses and civilian investigators.
- 6) Review newly obtained information which clearly indicates that January 6<sup>th</sup> unarmed protestor and honorably discharged Air Force Military Police veteran Ashli Babbitt was murdered by Capitol Police. Use of force protocols may not have been strictly followed and resulted in the tragic and untimely death of Ashli Babbitt. The entire cover-up and false narrative surrounding Ashli Babbitt's murder is a major center piece used by authorities involved in the January 6<sup>th</sup> investigation including the January 6<sup>th</sup> Congressional committee. If the FBI is truly concerned about "disinformation" potentially used to influence an election, then please correct this intentionally false narrative.
- 7) Investigate who within the FBI created the internal document used to educate FBI agents regarding DVE's (Domestic Violent Extremism). The timeline on the document is obviously intend to deceive agents within the FBI that the Bundy Ranch protest was a standoff between violent extremists and federal agents. Two federal courts have already determined that it was the FBI's own illegal misconduct, covert entrapment operation and withholding exculpatory information which caused acquittals in Oregon and a dismissal in Nevada of the Bundy defendants.
- 8) Immediately cease & desist utilizing surveillance technology housed in the Fort Washington, Maryland CIA facility without a search warrant, and for the purposes of spying upon Americans for political purposes. Additionally, cease & desist utilizing illegally obtained surveillance intelligence provided by private contractors.

Most, if not all details contained in the aforementioned demands have been thoroughly documented and investigated by me, and if called upon to do so I can testify truthfully under oath, and to the best of my knowledge. During my call to the FBI, I offered to become an "FBI informant" for the first time, especially since it was admitted by prosecutors in open federal court that 1000 online covert investigators were assigned to me --- who were actively involved in a COINTELPRO operation against me --- I might as well become an FBI informant. Unfortunately for some individual FBI agents, I have agreed to become an FBI informant to..... inform on the FBI.

If the FBI fails and refuses to publicly address these reasonable and lawful demands by October 19<sup>th</sup> 2022; and I fully expect that they will not; then I will have no alternative than to continue my efforts to inform the public of the corruption, misconduct and malfeasance within the FBI.

Please be informed that I am very understanding and compassionate towards my fellow Cincinnatians employed by the FBI and stationed here at the Cincinnati field office, and this letter is also to advise you that I intend to conduct a public prayer rally on October 20<sup>th</sup> 2022. We are calling it "Jesus for Justice", and we approximately 500-1000 people will gather outside your field office to pray for the following:

- 1) That Agents and personnel within the FBI field office do their job. Nothing more, and certainly nothing less, especially in light of the seriousness of the potential crimes that have been perpetrated by individuals within your own agency.
- 2) That Agents and personnel within the FBI field office who are prevented from doing their job and investigating these serious matters, will turn in their badge & gun, and join us ---your fellow American patriots --- at our prayer rally.
- 3) That all Agents and personnel within the FBI will do everything within their power and authority to end corruption within the agency. We pray that the good people within the agency put their country before their retirement & stop turning a blind eye to corruption.

We Americans are not domestic terrorists. We are law abiding citizens who believe in due process of and respect for the law. This is exactly why I come to you today.

Please partner with me in determining the truth. Please stop thinking that when people like me ask you to do the right thing, that I'm a threat to your safety or our country's security. You are being lied to by your superiors, and it's time to join together to counter the lies with truth....with Fidelity Bravery and Integrity.
